SUBJECT: Bylaws Committee Report

- 1. The Bylaws committee met on 23 January 2015 in Springdale, AR, on 1 February 2015 at the NGAA Building, and on 20 March 2015 at the NGAA Building to discuss proposed bylaws amendments. 7 Bylaw amendments were submitted prior to the cutoff date of 15 March 2015 to be considered by the general assembly for passage by a 2/3 majority vote. Any bylaws amendments after this date will require a 100% unanimous vote to secure passage.
- 2. We reviewed all 7 proposed bylaws changes for 2012. After discussion and debate, the following proposed amendments are submitted by paragraph to the Conference Delegates for consideration with committee recommendations.

Opening up the district to two positions per MACOM creates a larger pool of potential District Representatives to represent the same units.

Restructuring the Corporate membership levels allows for more options to potential sponsors and creates a wider opportunity for the Corporate Sponsorship team to target businesses with multiple levels and options, to include incentives for sponsorship at each level.

Life membership may be purchased prior to reaching age sixty. It shall be calculated by subtracting your present age from sixty, then multiply the result times your current membership dues, then add \$20.00.

Life membership may be purchased prior to reaching age sixty. A lifetime membership for the state Association will be \$140.

BACKGROUND:

With the recent lifetime dues restructure within EANGUS, the state association has almost out priced ourselves from members buying a lifetime membership into the association. The formula to calculate the rate also makes it more of a challenge to convince members to buy a lifetime membership. A simple, flat rate takes away any confusion and makes it an affordable option for the member.

SECTION 6: Membership shall be on an anniversary basis starting on the day the membership is paid for and processed then expiring the day prior to the one year anniversary of that membership. Multi-year memberships can be bought, but will expire the day prior of the final years anniversary.

BACKGROUND:

With a difference in membership rules between the National Association and the state Association, putting our members on an anniversary year membership versus a calendar membership keeps the state from having a drastic drop in membership on 01 JAN of each year as a result of every annual member expiring. It provides for a full year of membership no matter when a Soldier or Airmen joins.

BACKGROUND:

The Arkansas dues structure is complicated and sometimes confusing with the combined dues of the state and National Association. A simplified, flat rate is what the National Association uses, regardless of rank. Several other states have gone to the same thing, even as high as \$36 per person, regardless of rank, to help simplify the process and to make online transactions and rules simple and maintenance free.
